- ❖ At the time of counseling for the B.Ed. Course the candidates required to bring the following certificates/documents in original (01 set) and (01 set) of photocopy (self - attested) of each documents as mentioned below:

 - ✓ Secondary School Examination (10th) (Certificate) for Date of Birth Proof
 - ✓ Mark sheet and Certificate of Senior Secondary School Examination (10+2)
 - ✓ Final Year Mark sheet of UG/PG for proof of minimum eligibility.
 - ✓ In case of students who have passed the qualifying examination through distance/open education system of any recognized university the necessary documentary evidence related to location of his/her study center. i.e. study center proof, certificate from the university imparting open/distance education certifying the location of study center.
 - ✓ Character Certificate from the previous regular institute/college. (Not more than 6 months old)
 - ✓ Physical Fitness Certificate as per appendix 5 of GGSIPU, Delhi
 - ✓ Reserve Category certificate (if any) alongwith undertaking format Appendix 12 as per GGSIPU Prospectus 2026-27.
 - ✓ Undertaking by student with respect to anti-ragging by parent and guardian as per Appendix 6 and 7 of Admission Brochure for Academic Session 2026-2027.
- ❖ **No candidate will be allowed to attend the counseling without original certificates.**
